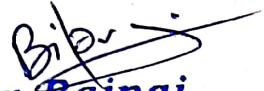
2nd place visited

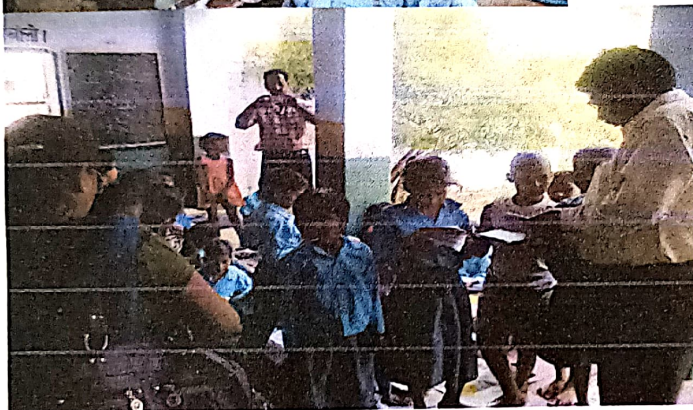
4th place visited

From the random checking of the above Schools, interaction with the local community, beneficiary children, it is found that the agency "VISHWAS SANSTHAN" Raebareli (U.P.) have conducted the survey for selection of people living in 50 rural villages in 2 blocks (Rahi & Sataw) of the District Rae Bareli in U.P. and conducted Health care campaigns, and have supplied education kits from the financial assistance received from ONGC. The village people have expressed their gratitude to ONGC for supporting the cause of the poor and needy people living in the above districts and requested to continue such supports by inclusion of more people in the beneficiary list, as out of 120 children studying in a particular school only 20 children are selected for the benefit and others are left out. The left out children may be considered for atleast giving some school stationery.
